\*Example for Line 5a calculation to transfer 45.0 acres of Primary Certificate 12345 (total 1.25 cfs for 100 acres) and 45.0 acres of Supplemental Certificate 87654 (1/80 cfs per acre) on the same land:

1. For irrigation calculate cfs for each water right involved as follows:
  - a. Divide total authorized cfs by total acres in the water right (for C12345,  $1.25 \text{ cfs} + 1.25 \text{ cfs} = 2.5 \text{ cfs}$ ) and multiply by the number of acres to be transferred to get the transfer cfs ( $\times 45 \text{ ac} = 0.56 \text{ cfs}$ ).
  - b. If the water right certificate does not list total cfs, but identifies the allowable use as  $1/40$  of an acre per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (For C87654,  $45.0 \text{ ac} \times 0.0125 \text{ cfs/ac} = 0.56 \text{ cfs}$ )
2. 

Additional remarks: Based on information provided by OWRD staff, we understand that the originating certificate for this right is ready to be issued as soon as the results of a pumping test are submitted and approved. Department staff have determined that the pumping test results from the proposed new well will likely be more representative of actual aquifer conditions; therefore, the new well is to be constructed and the pumping test performed before the certificate can be issued. This is the reason why a certificate number cannot be provided in this application. At the request of Department staff, this application is being submitted prior to issuance of a certificate in order to facilitate the review and approval of this proposed transfer.
