Water is pumped in a portable 5" water main that goes up an approximately 15 foot embankment to a system of 3" drop handlines. The hand lines are 40 feet long and each have 2 gallon per minute at 40psi sprinkler. A total of 120 sprinkler have been run at one time. Water is taken by bucket from the river for domestic use. Livestock drink directly out of the river.**
