Additional remarks:

Replacement of the rectangular old irrigation systems of linears, wheelines, etc with circular pivot systems necessitates the movement of water rights from the corners and other areas. Approximately 1,000 acres of the total of 6,000 acres of water rights on the farm are proposed for movement to accomplish this goal.
