**Purpose:**

THE APPLICANT REQUESTS THE TRANSFER OF EXISTING IRRIGATION WATER RIGHTS (UNDER CERTIFICAT 64160) FROM TAX LOT 1202 (ASSESSORS MAP 12-1W-29) TO PROPERTY ON WHICH HE OPERATES VAN ESSEN NURSERY. THE PROPERTY THAT IS TO RECEIVE THE TRANSFER IS TAX LOT 2800 (MAP 12-1W-19D). THE "FROM" LANDS CONTAINS 9.1 ACRES OF WATER RIGHTS FOR "IRRIGATION" PURPOSES. THIS TRANSFER APPLICATION REQUESTS: 1) CHANGE OF CHARACTER OF USE OF THE 9.1 ACRES FROM "IRRIGATION" TO "NURSERY OPERATIONS". 2) CHANGE IN PLACE OF USE; 3) CHANGE IN THE LOCATION OF POINT OF DIVERSION FROM POD "F" TO POD "B" THAT IS LOCATED 3650 FEET DOWN STREAM.
