

Additional remarks: Additional remarks: **The distribution of acres by quarter-quarter on the "From" map was generated using the most current and accurate data and corrects erroneously distributed acres on the permit and permit map. The description of acres by quarter-quarter on the "From" map reflects the same description as the permit map but the distribution has been corrected. The footprint of the permit map conforms to the general shapes of the subject tax lot, being 5S 4W TL 200. Additionally, neither Permit G-17338 nor the "From" map describe acres by DLC.**
