Additional remarks: The basic footprint of the original map for GR-1592 available in the Department's file appears to conform to the general shape of the subject tax lot (TL 4 2W 30 1500) but uses the DLC line for the east boundary. This alignment puts the western boundary of the mapped place of use into TL 4 2W 30 1400 which is covered by Certificate 30610. We believe the intended and correct alignment for the place of use under GR-1592 is entirely within Lot 1500 in accordance with Marion County Tax Map 4 2W 30, which shows the east boundary of Lot 1500 to be a short distance east of the DLC line. The proposed change in place of use for GR-1592 also makes the acreage by quarter-quarter section consistent with the place of use for the corresponding supplemental right under Cert 40138. Because the place of use for the supplemental right under Certificate 40138 appears to be entirely within Lot 1500 (ignoring the fact that the Final Proof Survey Map also appears to erroneously show the DLC line along the eastern boundary of the mapped place of use), there should be no need to submit a corresponding change in place of use transfer application for Certificate 40138.
