We harvest berries which cannot be irrigated from surface water three days before harvest due to possible bacteria. We wish to rely more on groundwater to avoid issues with the berries. The current authorized well is not functioning properly and needs to be replaced with additional wells to supply the full allowed rate. Upon completion and certification of this transfer, we intend to apply for a substitution to allow use of the groundwater right for primary irrigation.



