SUBJECT: Water Right Transfer Application T-11503

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-11503. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the Department's notice.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

#### Authority

Oregon Revised Statute (ORS) 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. Oregon Administrative Rule (OAR) Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

# **Applicant**

DRISCOLL STRAWBERRY ASSOCIATES, INC. C/O HOLLY BURGESS 434 REDCLIFF RD SUITE D REDDING, CA 96002

### **Findings of Fact**

- 1. On December 13, 2012, DRISCOLL STRAWBERRY ASSOCIATES INC.; C/O HOLLY BURGESS filed an application to change the place of use under Certificate 86143. The Department assigned the application number T-11503.
- 2. Notice of the application for transfer was published on December 18, 2012, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. In a December 16, 2013, letter the Department notified Driscoll Strawberries, applicant and James Newton, CWRE, that an additional \$250.00 fee is required because the application is to transfer more than one cubic foot per second of water.
- 4. The Department received the additional \$250.00 fee January 24, 2014.
- 5. In a December 16, 2013, letter the Department notified Driscoll Strawberries, applicant and James Newton, CWRE, that a refund of the \$125.00 fee they paid for Reimbursement Authority would be refunded as they immediately decided not to use Reimbursement Authority.
- 6. On January 6, 2014, the Department mailed a check in the amount of \$125.00 as refund for the Reimbursement Authority fee to Driscoll Strawberries Associates, Inc. c/o Holly Burgess.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 7. After discussion with the applicant's agent, James Newton, regarding the lands involved in the transfer, in a February 4, 2014, email, James Newton approved the amended Table 2 Description of Changes to Water Right Certificate 86143. The amendments clarify the acres on specific tax lots and/or government lots and/or donated land claims.
- 8. On February 19, 2014, the Department sent a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11503 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of March 19, 2014, for the applicant to respond. The deadline was extended to April 3, 2014.
- 9. On May 14, 2014, the Department received a request from the applicant's agent requesting that the file be put on Administrative Hold. The file was placed on Administrative Hold until November 14, 2014.
- 10. On November 14, 2014, the Department received a request from the applicant's agent requesting that the file be put on another Administrative Hold. The file was placed on Administrative Hold until May 14, 2015.
- 11. On May 14, August 11, and 13, 2015, the applicant's agent submitted amended documents decreasing the number of acres in the application and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer. The applicant requested that the Department proceed with issuance of a Preliminary Determination with the changes as described in the amended application.
- 12. The portion of the right to be transferred is as follows:

Limit/Duty:

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-EIGHTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation

season of each year.

## Transfer Review Criteria (OAR 690-380-4010)

- 14. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the right is subject to forfeiture under ORS 540.610.
- 15. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right were present within the five-year period prior to submittal of Transfer Application T-11503.
- 16. There is a Klamath claim (KA 1000) existing on both the "From" and "To" lands.
- 17. The proposed change would not result in enlargement of the right.
- 18. The proposed change would not result in injury to other water rights.
- 19. All other application requirements are met.

### **Determination and Proposed Action**

The change in place of use proposed in Transfer Application T-11503 appears to be consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the application will be approved.

If Transfer Application T-11503 is approved, the final order will include the following:

- 1. The change in place of use proposed in Transfer Application T-11503 is approved.
- The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificate 86143 and any related decree.
- 3. Water right Certificate 86143 is cancelled. A new certificate will be issued describing that portion of the right not affected by this transfer.
- 4. Water use measurement conditions:
  - a) Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device at each point of appropriation (new and existing).
  - b) The water user shall maintain the meters or measuring devices in good working order.
  - c) The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice. Water shall be acquired from the same aquifer (water source) as the original points of appropriation.
- 5. The former place of use of the transferred right shall no longer receive water under the right.
- 6. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2016. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change and full beneficial use of the water.
- 7. After satisfactory proof of beneficial use is received, a new certificate confirming the right transferred will be issued.
