1. For irrigation calculate cfs for each water right involved as follows:

- a. Divide total authorized cfs by total acres in the water right (for C12345, 1.25 cfs \div 100 ac); then multiply by the number of acres to be transferred to get the transfer cfs (x 45 ac = 0.56 cfs).
- b. If the water right certificate does not list total cfs, but identifies the allowable use as 1/40 or 1/80 of a cfs per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (For C87654, 45.0 ac x 0.0125 cfs/ac = 0.56 cfs)

Additional remarks: <u>I do not believe that the map for Juniper Flat DIC is totally accurate in describing the place of use on my property. I</u> have 90 acres of JFDIC irrigation water rights. I wish to move 5 acres off and leave the remaining 85 acres in the center pivot. In the above

table all of the water rights on Tax Lot 3000 are listed on the left as described in the certificate. On the right it shows I am moving 5 acres and what I believe is the correct location of the remaining 85 acres within the center pivot.

<u># the number listed is the number of acres being converted from irrigation to pond maintenance. Juniper Flats tracks these uses as "acre equivalents" to know how much to assess the landowner for and how much water to deliver.</u>


