Explain in your own words what you propose to accomplish with this transfer application, and why: This application proposes a permanent change in use for App. No. R-41732 / Permit No. R4739 / Certificate No. 51764, adding industrial use to the existing recreation use. Water will be hauled from the reservoir to be used for hydrostatic testing and dust control during construction of the Pacific Connector Gas Pipeline Project. The total amount of water used for industrial use is approximately 10.18 acre-feet (3,315,584 gallons). The water right certificate for Kinnan Lake allows for storage of up to 395 acre-feet per year.


