

Explain in your own words what you propose to accomplish with this transfer application; and why: We want to temporarily transfer an existing irrigation right to establish a filbert orchard with 20 ft. row spacing. We intend to drip irrigate the new trees in 4 ft. wide strips, so we would like to transfer 16 ft. wide strips @ 20 ft. on centers from the existing place of use to 4 foot wide strips @ 20 ft. on center to the new places of use while keeping 4 foot wide strips @ 20 ft. on center remaining on the existing place of use. There are 1.5 acres that remain unchanged. There are no changes in the existing points of diversion.




