SUBJECT: Water Right Transfer Application T-12217

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-12217. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication and in the Central Oregonian newspaper, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the last date of newspaper publication.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

Authority

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications. ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

Applicant

WAIBEL RANCHES LLC 3672 SW JUNIPER CANYON RD PRINEVILLE, OR 97754

Findings of Fact

- 1. On December 14, 2015, WAIBEL RANCHES LLC filed an application for an additional point of diversion, to change the points of diversion, to change the place of use, and cancellation of a portion of a water right under Certificates 606 and 51366. The Department assigned the application number T-12217.
- 2. Notice of the application for transfer was published on December 22, 2015, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On February 22, 2016, the agent for the applicant submitted a revised application and map and an affidavit for partial cancellation of water right certificate 606.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 4. On April 7, 2016, the Department sent a copy of the draft Preliminary Determination proposing to approve Transfer Application T-12217 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of May 9, 2016, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 5. The first right to be transferred is as follows:

Certificate: 606 in the name of JOSEPH LISTER (confirmed by Crooked River

Decree)

Use: IRRIGATION OF 111.0 ACRES, AND STOCK AND DOMESTIC USE

Priority Dates: 1882 FOR 40.0 ACRES, 1895 FOR 30.0 ACRES, 1898 FOR 41.0 ACRES

Rate: 1.4 CUBIC FEET PER SECOND

Limit/Duty: The amount of water to which such right is entitled and hereby confirmed

for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for domestic and stock use, and 1.4 cubic feet per second for irrigation from

February 1st to December 1st of each year.

- 8. A scrivener's error was found in Certificate 606. The irrigation season was described from July 1st to September 15th, however information is available in the Crooked River Decree that states the irrigation season is in fact from February 1st until December 1st of each year.

13. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screen is necessary at the new point of diversion to prevent fish from entering the diversion and that the diversion is not currently equipped with an appropriate fish screen. This diversion may be eligible for screening cost-share funds.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 14. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 15. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-12217.
- 16. The proposed changes would not result in enlargement of the rights.
- 17. The proposed changes would not result in injury to other water rights.

Partial Cancellation of a Water Right

1. On February 22, 2016 an affidavit certifying that a portion of a water right has been abandoned and requesting cancellation of the right was received from Brad Waibel. The right to be cancelled is as follows:

Determination and Proposed Action

The additional point of diversion, change in points of diversion, change in place of use, and partial cancellation of a water right proposed in Transfer Application T-12217 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and the requested portion of the abandoned right should be cancelled. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved and the abandoned portion of the right will be cancelled.

If Transfer Application T-12217 is approved, the final order will include the following:

- 1. The additional point of diversion, change in points of diversion, and change in place of use proposed in Transfer Application T-12217 are approved. The portion of the right that has been abandoned is cancelled.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 606 and 51366 and any related decree.
- 3. Water right Certificate 606 is cancelled.
- 4. Water right Certificate 51366 is cancelled. A new certificate will be issued describing that portion of the right not affected by this transfer and cancellation.
- 5. The quantity of water diverted at the additional point of diversion, together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.
- 6. The quantity of water diverted at the new points of diversion shall not exceed the quantity of water lawfully available at the original points of diversion.

- 7. Water use measurement conditions:
 - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each new point of diversion.
 - b. The water user shall maintain the meters or measuring devices in good working order.
 - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 8. The water user shall operate and maintain an approved fish screen at the new point of diversion. If Oregon Department of Fish and Wildlife (ODFW) determined the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.
- 9. The former place of use of the transferred rights shall no longer receive water under the rights.
- 10. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2017. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

11. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
