Explain in your own words what you propose to accomplish with this transfer application, and why:  
 We propose to Change the Character of Use for this 1 ac-ft storage right for stock water to a multi-purpose right to accomplish two things: (1) return this unnamed tributary to the McMahan Branch of Mud Slough to its natural status as an ephemeral stream by lifting this perennial right of storage, and (2) make water that is already in storage available for wildlife, aesthetics, recreation, and subsequently for irrigation and commercial use via future filings for appropriation.

The Capra Company has a pending Limited Water Use License filed for Crop Establishment on the same property adjoining this storage right, Reference No. LL-1643. Returning this unnamed tributary to that status would allow for placement of wells under the Limited License further from blue line creeks by removing the perennial status of this storage right on what is an ephemeral stream. This change would allow for evaluation of an existing domestic well on the property for risks of Substantial Interference as being more than a 1/4 mile from a blue line creek under Limited License Application No. LL-1643


