**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That GUSTAVE HOFFMAN**

of Route 2, Box 538, Hillsboro, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of one well

a tributary of Tualatin River for the purpose of irrigation of 14.3 acres

under Permit No. G-563 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 10, 1957.

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected within McIlinn DIC 40, Section 2, T. 1 S., R. 3 W., S. M. Well is 325 feet N. and 560 ft. W. from the S.E. corner, McIlinn DIC 40.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

13.0 acres SW $\frac{1}{4}$  NW $\frac{1}{4}$  as projected within McIlinn DIC 40  
 Section 2  
 1.3 acres SE $\frac{1}{4}$  NE $\frac{1}{4}$  as projected within McIlinn DIC 40  
 Section 3  
 T. 1 S., R. 3 W., W. M.

Land on which water is to be used part of that described as follows:

Commencing at the SE corner of McIlinn DIC 40 and running th. N. on E. line of said Wm. McIlinn DIC 6.695 chs. to NE corner of tract conveyed to Andrew Miller, for beginning point of tract to be conveyed by this deed, running W. from said beginning point, and on the N. line of said Miller tract, 11.95 chs. to N.W. corner thereof, said corner being in center of county road, th. N. 5.858125 chs. to a point in center of said county road; thence E. parallel with S. line of this tract hereby conveyed to E. line of said Wm. McIlinn claim; th. S. on E. line of said McIlinn claim to place of beginning. ALSO: Commencing at SE corner of McIlinn DIC 40 running th. W. on S. line of said D.L.C. 11.95 chs. to center of present county road; th. N. in center of said county road 6.695 chs. to a post; th. E. parallel with S. line of said D.L.C. 11.95 chs. to E. line of said D.L.C.; thence S. on E. line thereof to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
