The existing well has, to some extent, collapsed and is unserviceable. I have contacted a well driller about repairing the existing well and have been told to do so would require installing a smaller casing as the existing well does not have an appropriate well seal. The smaller casing would not be large enough to accommodate the irrigation pump, therefore, I want to drill a replacement well.
