Explain in your own words what you propose to accomplish with this transfer application, and why: Sixty eight point six (68.6) acres of farmland is changing from crops requiring water application to the entire field via center pivot sprinkler system to rows of blueberries which will receive water within 3-foot rows with 12-foot center offset, via a new drip irrigation system. The portions of two water rights which cover the dry strips between the blueberry rows are being transferred out to new lands elsewhere on the same tax lot.
