SUBJECT: Water Right Transfer Application T-11983

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-11983. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication and in the Malheur Enterprise newspaper, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the last date of newspaper publication.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

# **Authority**

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications. ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

## Findings of Fact

- 1. On February 19, 2015, WILLIAM L. AND CINDY R. ROMANS filed an application to change the points of diversion, change the place of use, change the character of use from supplemental irrigation to primary irrigation under Certificates 6954, 51081, 51082, 51105, 51106, 51107, 51108, 51109, and 51934, a cancellation of a water right under Certificate 51114, and a partial cancellation of a water right under Certificate 51083. The Department assigned the application number T-11983.
- 2. Notice of the application for transfer was published on March 3, 2015, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On March 22, 2016, the applicant submitted a revised application and maps.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 4. On August 12, 2016, the Department sent a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11983 to the applicants. The draft Preliminary Determination cover letter set forth a deadline of September 12, 2016, for the applicants to respond. The applicants requested that the completion date be extended to October 1, 2022 and for Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicants are authorized to pursue the transfer.

34. Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screen is necessary at the new points of diversion to prevent fish from entering the diversion and that the diversion is not currently equipped with an appropriate fish screen. The diversion may be eligible for screening cost-share funds.

# Transfer Review Criteria [OAR 690-380-4010(2)]

- 35. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 36. A diversion structure and ditch sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11983.
- 37. The proposed changes would not result in enlargement of the rights.
- 38. The proposed changes would not result in injury to other water rights.

## **Determination and Proposed Action**

The change in points of diversion, change in place of use, change in character of use and cancellation and partial cancellation of a water right proposed in Transfer Application T-11983 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and the abandoned rights should be cancelled. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved and the abandoned rights will be cancelled.

If Transfer Application T-11983 is approved, the final order will include the following:

1. The change in points of diversion, change in place of use, and change in character of use from supplemental to primary irrigation proposed in Transfer Application T-11983 are approved. The entire water right and portions of a water right that have been abandoned are cancelled.

- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 6954, 51081, 51082, 51105, 51106, 51107, 51108, 51109, and 51934 and any related decree.
- 3. Water Right Certificates 51109 and 51114 are cancelled.
- 4. Water right Certificates 6954, 51081, 51082, 51083, 51105, 51106, 51107, 51108, and 51934 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer and cancellation.
- 5. The quantity of water diverted at the new points of diversion, together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.
- 6. Water use measurement conditions:
  - a. Before water use may begin under this order, the water user shall install a weir, or, with prior approval of the Director, another suitable measuring device, at each point of diversion new and existing.
  - b. The water user shall maintain the weirs or measuring devices in good working order.
  - c. The water user shall allow the Watermaster access to the weirs or measuring devices; provided however, where the weirs or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 7. Prior to diverting water, the water user shall install headgates to control and regulate the quantity of water diverted. The type and plans of the headgates must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain the headgates as required by the Department.
- 8. Prior to diverting water, the water user shall install an approved fish screen at the new points of diversion and shall provide to the OWRD a written statement from Oregon Department of Fish and Wildlife (ODFW) that the installed screens meet the state's criteria, or that ODFW has determined a screen is not necessary.
- 9. The water user shall operate and maintain the fish screen at the new points of diversion consistent with ODFW's operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.
- 10. The former place of use of the transferred rights shall no longer receive water under the rights.
- 11. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2022. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.


12. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
