Applicable Law

Any person or group of persons holding a water use subject to transfer as defined in ORS 540.505 may submit an application for an Allocation of Conserved Water to the Water Resources Commission for a conservation project that has not yet been implemented or was implemented within five years prior to the submission of the application. ORS 537.465. Under the Allocation of Conserved Water Program, a portion of the water proposed to be conserved by an applicant may be used on additional lands, put to a different use, or be leased or sold to another user. OAR 690-018-0010. A portion of the water conserved is allocated to the state to be converted to an instream water right or to revert to the public for appropriation by other water users. ORS 537.470(3).

An application for an allocation of conserved water shall include: (a) A description of the measure as implemented and the date on which the measure was implemented; (b) A description of the diversion facilities before the conservation measure was implemented and the amount of water that was diverted at the facilities before the conservation measure was implemented; (c) The amount of water needed to supply existing rights after implementation of the conservation measure; (d) The amount of water conserved by implementing the conservation measure; (e) The proposed allocation and use of the conserved water if different from the allocation specified in ORS 537.470; (f) The intended use of any water allocated to the applicant; (g) The applicant’s choice of priority date for the conserved water; (h) Evidence that the measure was implemented within five years prior to the date of filing the application; and (i) Any other information the commission considers necessary to evaluate the application. ORS 537.465.

After determining any quantity of water needed to mitigate the effects on other water rights, 25-percent of the conserved water shall be allocated to the state and 75-percent to the applicant unless the applicant proposes a higher allocation to the state or more than 25-percent of the funds used to finance the conservation measures comes from federal or state sources. ORS 537.470(3).

Pursuant to OAR 690-018-0050, any person objecting to the proposed allocation may file a protest to this Preliminary Determination with the Water Resources Commission within 60 days of the mailing of this determination.

If an application for the allocation of conserved water is approved, the Department shall issue orders describing the changes in the original water rights. Once the conservation project is finalized, the Department shall issue new certificates preserving the previously established-priority date of the rights to reflect the unaffected portion of the water rights. ORS 537.470(6).

ORS 537.455 to 537.500 authorize and establish the process by which a water right holder may submit a request for an allocation of conserved water. OAR Chapter 690, Division 18, implements the statutes and provides the Department’s procedures and criteria for evaluating allocation of conserved water applications. OAR Chapter 690, Division 077 provides additional criteria for evaluating proposed instream water rights.

Findings of Fact

1. On September 20, 2016, Farmer’s Irrigation District (Applicant) filed an allocation of conserved water application under Certificate 74299. The Department assigned the application number CW-92.
2. On August 17, 2016, Farmer’s Irrigation District (FID) adopted an Allocation of Conserved Water Policy pursuant to OAR 690-018-0025.
3. The conservation project is a delivery system improvement project. The conservation measure involves replacing 2.1 miles of rusty and leaky galvanized pipe and ADS pipe of the North Green Point pipeline with HDPE pipe eliminating seepage losses. The replacement of leaky pipes eliminating seepage losses is a proven technology for conserving water.
4. On November 1, 2016, Farmers Irrigation District amended its application by clarifying the maximum quantity of water to be conserved.
5. Application CW-92 proposes a rate reduction of approximately 1.5 cubic feet per second (cfs) and proposes to reduce the annual volume by 357.0 acre-feet (AF).

6. The portion of the right to be modified by CW-92 is as follows:

Certificate: 74299 in the name of FARMER’S IRRIGATION DISTRICT, confirmed by the Hood River Decree

Use: IRRIGATION of 1936.8 ACRES, being 191.7 acres PRIMARY IRRIGATION, and 1745.1 acres SUPPLEMENTAL IRRIGATION

Priority Date: December 1, 1905

Rate: 37.5 CUBIC FEET PER SECOND (cfs), being 10.0 cfs from North Fork Green Point Creek, 15.0 cfs from South Fork Green Point Creek, 10.0 cfs from Dead Point Creek, and 2.5 cfs from South Fork Pine Creek, or its equivalent in case of rotation, measured at the source.

This right is subject to the provision which provides that total quantity diverted from all sources at any one time under this Certificate together with Certificates 74298 [superseded by 85974] and 74300 [superseded by 85975] shall not exceed 31.62 cfs.

Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

7. Certificate 74299 contains scrivener’s errors in the legal descriptions of the points of diversion for North Fork and South Fork Green Point Creeks. The corrections are indicated in bold on the above descriptions.
8. The conservation measure identified in Finding of Fact #3 is applicable only to the point of diversion on North Fork Green Point Creek.
9. Certificate 74299 does not describe the period of use of the right. Under the terms and conditions of the Final Decree of the Circuit Court for Hood River County dated October 24, 1921, the irrigation season was fixed as beginning on the 15th day of April and ending on the 1st day of October of each year (Decree Finding No. 23). However, additional information is available from the decree indicating the duty allowed for the right is 3.0 acre-feet/acre (AF/ac), with a rate of 1/80 cfs/acre (Decree Finding No. 28) for 120 days.
10. Water has been used within the five-year period prior to submission of the allocation of conserved water application, and no evidence is available that would demonstrate that the right is subject to forfeiture under ORS 540.610.

11. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right were present within the five-year period prior to submittal of the application.
12. The Applicant requests that the conserved water be allocated as follows:

13. The Applicant proposes that its portion of the conserved water be allocated for an out-of-stream use within the boundaries of Farmers Irrigation District, more specifically in Township 2 North, Range 10 East, W.M., Sections 4, 8, 9, 10, 15, 16, 17, 18, 19, and 20.
14. The Applicant requests that the priority date for any conserved water be one minute junior to the originating right.
15. The Applicant received non-reimbursable state funds. The Applicant proposes 75% of the conserved water be allocated to the state. The Applicant will retain 25% of the conserved water for its use. ORS 537.470(3)
16. The Applicant submitted a completed Land Use Form from Hood River County which indicated the proposed use was allowed outright or is not regulated under Section 502 of Hood River County's Zoning ordinance.
17. The construction of the conservation measures was set to begin no earlier than October 1, 2016.
18. The Applicant proposes that any instream water right created be for the purposes of conservation, maintenance, and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat, and other ecological values. The Applicant submitted letters in support of the project from the Oregon Department of Fish & Wildlife mid-Columbia District Biologist, and the Confederated Tribes of the Warm Springs Indians.
19. The Applicant requested the Department protect the new instream water right created from the conserved water under Certificate 74299 from the authorized point of diversion on North Fork Green Point Creek to the confluence with Green Point Creek located in the NENW of Section 10, Township 1 North, Range 9 East, W.M., then further protected in Green Point Creek to the mouth at the confluence with West Fork of Hood River located in the SENW of Section 12, Township 1 North, Range 9 East, W.M.
20. The Applicant requested the deadline for submitting the Notice of Completion of December 16, 2016. The Applicant will submit a Request for Finalization on or before finalization of the allocation on or before September 30, 2021.
21. The application meets the requirements of OAR 690-018-0040.

22. The Applicant submitted letters of support from the Oregon Department of Fish and Wildlife Fish Biologist and the Confederated Tribes of the Warm Springs Indians. The letters provide support for the project and indicate the instream flows are necessary to support instream flow uses.
23. Notice of the proposed conservation project was published in the Department's weekly notice on October 11, 2016, and in the Hood River News newspaper on October 15 and 23, 2016, as required under OAR 690-018-0050(1)(a) and (2). No comments were filed in response to the notices.

Allocation of Conserved Water Review Criteria [OAR 690-018-0050]

24. The proposed allocation of conserved water will result in a reduced diversion of the use allowed under the existing right pursuant to OAR 690-0018-0050(4)(a). (Finding of Fact #5).
25. On November 3, 2016, the District #3 Watermaster performed a review of the proposed Allocation of Conserved Water Project. The Watermaster determined that the conservation project would not harm other water rights; therefore, no quantity of conserved water is needed to mitigate for harm to other water rights. OAR 690-018-0050(4)(b) and (d).
26. The conservation project is consistent with the local comprehensive land use plan requirements established in OAR 690-005-0045. (Finding of Fact #16). OAR 690-018-0050(4)(c).
27. Pursuant to OAR 690-018-0050(4)(e), the new reduced rate and duty for the existing uses involved in Allocation of Conserved Water Application CW-92 under Certificate 74299 are as follows:

28. Pursuant to OAR 690-018-0050(4)(e), the rate and volume allocated to the State for instream use is as follows:

29. As required by OAR 690-018-0050(4)(f), the Department has determined that the instream right created will support public benefits. The proposed instream water right does not propose to protect flows in the West Fork Hood River; however, flows are protected from the authorized point of diversion on North Fork Green Point Creek, into Green Point Creek to the mouth located at the confluence of West Fork Hood River. The West Fork of Hood River provides critical habitat for steelhead, Chinook salmon, and Coho salmon which are listed as threatened species under the Endangered Species Act. (Finding of Fact #18).

30. Pursuant to ORS 537.470(3) and OAR 690-018-0050(4)(g), the amount of water allocated to the Applicant does not need to be adjusted because the Applicant is taking the minimum amount allowed under ORS 537.470(3). (Finding of Fact #15). The rate and volume allocated to the Applicant is as follows:

31. The new instream water right created will be protected from the authorized point of diversion on North Fork Green Point Creek as described in Finding of Fact #6 to the confluence with Green Point Creek located in the NENW of Section 10, Township 1 North, Range 9 East, W.M., then further protected in Green Point Creek to the mouth at the confluence with West Fork of Hood River located in the SENW of Section 12, Township 1 North, Range 9 East, W.M.
OAR 690-018-0050(4)(h); OAR 690-077-0015(8).

32. The State’s portion of conserved water may be protected for 120 days during the irrigation season without enlarging the right.

33. The instream right shall allow the use and protection of flows as follows:

34. The amount and timing of the proposed instream flows are allowable within the limits and use of the original water right. OAR 690-077-0015(10).

35. The protection of flows within the proposed reach is appropriate, considering:
- The instream water use begins at the recorded point of diversion;
 - The location of confluences with other streams downstream of the point of diversion.
 - There are no known areas of natural loss of streamflow to the river bed downstream from the point of diversion; and
 - Any return flows resulting from the exercise of the existing water right would re-enter the river downstream of the reach of the instream water right.
- OAR 690-077-0015(8).

36. The combination of instream rights for the proposed reaches on the North Fork Green Point Creek and Green Point Creek do not exceed the amount needed to provide increased public benefits, and do not exceed the estimated average natural flow or level occurring from the drainage system. OAR 690-077-0015(4) and (11).

37. There are no existing instream water rights established pursuant to ORS 537.341 (minimum flow conversion) or ORS 537.336 (state agency process) on the North Fork Green Point Creek or the Green Point Creek. By adding to other instream water rights established pursuant to ORS 537.348 (instream transfer process) and ORS 537.470 (allocation of conserved water process) located within the proposed reach, any new instream water rights established by this conserved water project would provide protection for additional flows identified as necessary

for conservation, maintenance, and enhancement of aquatic and fish life, wildlife, fish and wildlife habitat, and other ecological values. OAR 690-077-0015(11).

38. The proposed areas within which the conserved water is proposed to be used for out-of-stream uses are within Sections 4, 8, 9,10, 15, 16, 17, 18, 19, and 20 of Township 2 North, Range 10 East, W.M. (Finding of Fact #13). OAR 690-018-0050(4)(h).
39. The deadline for submitting a Notice of Completion is December 16, 2016. The deadline for submitting a Request for Finalization is September 30, 2021. (Finding of Fact #20). OAR 690-018-0050(4)(i).
40. No other conditions or limitations are needed to prevent or mitigate for harm to existing water rights. (Finding of Fact #25). OAR 690-018-0050(4)(j).

Determination and Proposed Action

The project described in Allocation of Conserved Water Application CW-92, is consistent with the criteria in ORS 537.455 to 537.500, and OAR Chapter 690, Divisions 018 and 077. If protests are not filed pursuant to OAR 690-018-0050(b), the conserved water application will be approved.

If Allocation of Conserved Water Application CW-92 is approved, the Order Approving will include the following:

1. *The proposed change will result in a reduced diversion for the uses allowed under the original water right. Findings of Fact #5 and 24.*
2. *The proposed allocation of conserved water will not harm existing water rights. Finding of Fact #25.*
3. *The application is consistent with the requirements established in OAR 690-005-0045. Finding of Fact #26.*
4. *The changes proposed in CW-92 are approved.*
5. *The deadline for submission of the Notice of Completion is December 16, 2016. The Deadline for submission of the Request for Finalization is September 30, 2021.*

Upon Filing of the Notice of Completion, the Order will include the following:

7. *The right to the use of the water is restricted to beneficial use at the places of use described, and is subject to all other conditions and limitations contained in Certificate 74299 and any related decree.*

8. *Water Right Certificate 74299 is cancelled. Upon submission of Request for Finalization, a superseding Certificate will be issued for the existing uses and place of use at the reduced rate and duty as follows:*

Use: *IRRIGATION of 191.7 ACRES, SUPPLEMENTAL IRRIGATION OF 1733.5 ACRES, AND 11.6 ACRES OF INCHOATE SUPPLEMENTAL IRRIGATION*

Priority Date: *DECEMBER 1, 1905*

Rate: *36.0 CUBIC FEET PER SECOND (cfs), being 8.5 cfs from North Fork Green Point Creek, 15.0 cfs from South Fork Green Point Creek, 10.0 cfs from Dead Point Creek and 2.5 cfs from South Fork Pine Creek*

Limit/Duty: *This right is subject to the provisions of Finding No. 15 of the Hood River Decree which provides the total quantity diverted from all sources at any one time under this Certificate together with Certificates 85974 and 85975 shall not exceed 31.62 cfs (2529.4 primary acres multiplied by 1/80 cfs per acre).*

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 ACRE-FEET for each acre irrigated during the irrigation season of each year.

This certificate describes the water right confirmed by Certificate 74299 State Record of Water Right Certificates, REDUCED IN RATE by the provisions of an order of the Water Resources Department entered _____, approving and finalizing Allocation of Conserved Water CW-92, and confirms the Department's determination of satisfactory proof of completion of changes authorized by orders of the Director for water right transfers T-8152, T-8386, T-8650 and T-11189. This Certificate together with Certificate _____ (ISWR), supersedes Certificate 74299.

In addition, this Certificate includes the portion of the water right described by Certificate 74299, State Record of Water Right Certificates, modified by the provisions of orders of the Water Resources Director approving Transfer Applications: 1) T-11528, recorded on October 5, 2015, in Special Order Volume 98, Page 31; 2) T-11935, recorded on April 24, 2015, in Special Order Volume 95, page 953, and 3) T-12254, recorded on February 29, 2016, in Special Order Volume 98, Page 1014. The modifications under Transfers T-11528, T-11935, and T-12254 are listed as inchoate lands in the place of use above.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.



NOTICE OF RIGHTS

The Legislative Assembly finds that persons affected by actions taken by state agencies have a right to be informed of their rights and remedies with respect to those actions. ORS 183.415.

The Commission shall notify the applicant and any other person requesting notice, of the action the Commission intends to take under ORS 537.470(3). Any person objecting to the proposed allocation may file a protest requesting a contested case hearing before the Commission. ORS 537.470(4).

If a protest to the proposed allocation of conserved water is received by the Department within 60 days of the mailing of the preliminary determination pursuant to ORS 537.470(4) and OAR 690-018-0050(4), the Director may work with the applicant and any protestant to determine whether the issues can be resolved through mutually agreeable conditions, or by modifying the application. OAR 690-018-0050(6).

If protests are received raising issues that cannot be resolved pursuant to OAR 690-018-0050(6), the Director shall present the application, all protests and a recommendation for action to the Commission for review and action. OAR 690-018-0050(8).

The Commission shall examine the application, the protests and the Director's recommendation. If the Commission finds the allocation of conserved water is likely to injure existing water rights or is otherwise inconsistent with these rules, the Commission may direct the Department to hold a contested case hearing on the application pursuant to ORS 183.413 and OAR 690, Divisions 1 and 2 or to resume attempts to resolve the disputed issues. If the Commission finds the allocation of conserved water is not likely to injure existing rights and is otherwise consistent with OAR 690-018-0050, the Commission may authorize the Director to issue an order approving the application. OAR 690-018-0050(9).

In the event of a land use dispute, as defined in OAR 690-005-0015, the Director shall follow resolution procedures provided in 690-005-0040 (Resolution of Land Use Disputes). OAR 690-018-0050(10).
