

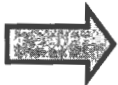

The proposed wells A, B, C, and/or D will comply with the current permit conditions for Permit G-16687 that requires the well(s) to produce groundwater only from the bedrock groundwater reservoir. The source of water is proposed to be the same as the McGinn Washout Well (L-107025), which is closer to Hutchinson Hill.
