SUBJECT: Water Right Transfer Application T-11699

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-11699. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication and in the East Oregonian newspaper, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the last date of newspaper publication.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

Authority

ORS 540.505 to 540.580 establishes the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. OAR Chapter 690, Division 380 implements the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Applicants

Findings of Fact

- 1. On December 13, 2013, BRIAN S. THOMPSON AND BERNARD DAMON filed an application for an additional point of diversion under Certificates 156, 87876, 87877, 87878, 114, and 87565. The Department assigned the application number T-11699.
- 2. Notice of the application for transfer was published on December 17, 2013, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On February 24, 2014, the Department contacted the applicant's agent, William Porfily, by email to notify him of the deficiencies in the application. On March 5, 2014, the Department received an amended application from the agent, by email, resolving the deficiencies in the application.
- 4. On March 10, 2014, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-11699 to the applicants. The draft Preliminary Determination cover letter set forth a deadline of April 9, 2014, for the applicants to respond.
- 5. On April 23, 2014, the applicants requested the application be put on Administrative Hold until October 20, 2014. On November 28, 2014, the application was again put on Administrative Hold until additional meetings could be held and the project could continue.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 6. On April 1, 2016, the Department received an amended application from the applicants agent, the amended application included additional water right Certificates 4863, 7057, 30021, 64312, 80055, 82489, 82490 and 87565.
- 7. Notice of the application for transfer with the additional eight water right Certificates, was published on October 4, 2016, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 8. During the months of October and December, 2016, the Department contacted the applicants' agent by email to notify of the deficiencies in the application. On December 19 and 21, 2016, the Department received an Evidence of Use affidavit, Land Use form, and an amended application resolving the deficiencies and removing water right Certificates 30021, 82489 and 82490 from the application.
- 9. On January 6, 2017, the Department mailed a copy of the amended draft Preliminary Determination proposing to approve Transfer Application T-11699 to the applicants. The draft Preliminary Determination cover letter set forth a deadline of February 5, 2017, for the applicants to respond. The applicants requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

25. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screen is necessary at the new point of diversion to prevent fish from entering the diversion and that the diversion is not currently equipped with an appropriate fish screen. This diversion may be eligible for screening cost-share funds.

Transfer Review Criteria [OAR 690-380-4010(2)]

26. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.

- 27. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-11699.
- 28. The proposed change would not result in enlargement of the rights.
- 29. The proposed change would not result in injury to other water rights.

Determination and Proposed Action

The additional point of diversion proposed in Transfer Application T-11699 appears to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved.

If Transfer Application T-11699 is approved, the final order will include the following:

- 1. The additional point of diversion proposed in Transfer Application T-11699 is approved.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 114, 156, 4863, 7057, 64312, 80055, 87565, 87876, 87877 and 87878 and any related decree.
- 3. Water right certificates 114, 156, 4863, 7057, 64312, 80055, 87565, 87876, 87877 and 87878 are cancelled.
- 4. The quantity of water diverted at the additional point of diversion, together with that diverted at the original points of diversion, shall not exceed the quantity of water lawfully available at the original points of diversion.
- 5. Water use measurement conditions:
 - a. **Before water use may begin** under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each new point of diversion.
 - b. The water user shall maintain the meters or measuring devices in good working order.
 - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 6. In order to avoid enlargement of the right or injury to other rights, it is preferable to have a flowmeter installed that reads instantaneous, totalizes, and has real-time access so the Watermaster can access the flow data. However, if the flowmeter will not work and provide the real time data, the Watermaster can approve an alternate type of measuring device that will provide instantaneous data, totalizes, and will provide real time access to the flow data.
- 7. Prior to diverting water, the water user shall install a headgate to control and regulate the quantity of water diverted. The type and plans of the headgate must be approved by the Department prior to beginning construction and shall be installed under the general supervision of the Department. The water user shall maintain the headgate as required by the Department.

- 8. Prior to diverting water, the water user shall install an approved fish screen at the new point of diversion and shall provide to the OWRD a written statement from Oregon Department of Fish and Wildlife (ODFW) that the installed screen meets the state's criteria, or that ODFW has determined a screen is not necessary.
 - The water user shall operate and maintain the fish screen at the new point of diversion consistent with ODFW's operational and maintenance standards. If ODFW determines the screen is not functioning properly, and is unsuccessful in working with the water user to meet ODFW standards, ODFW may request that OWRD regulate the use of water until OWRD receives notification from ODFW that the fish screen is functioning properly.
- 9. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before October 1, 2018. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the change and full beneficial use of the water.
- 10. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
