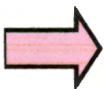

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use. **We are relatively new land owners and the irrigated land is leased out to an individual who continues to lease that land after our purchase. He tells us that the pump in the well will put out about 300 gpm. We have observed that he can run one line across the field southeast of Eightmile Creek (maximum of 38 sprinklers) and one line in one of the fields between the county road and Eightmile Creek (average of 13 sprinklers). This 51 sprinklers would be close to between 285 and 300 gpm.**

A water right application is being made simultaneously on the same well to use water during the non-irrigation season. The initial use under the Agricultural Nursery is for the purposes of a licensed marijuana growing operation. If that fails or some other crop becomes more profitable we do not wish to be limited to a single crop.
