On behalf of the applicant, Roseburg Forest Products (RFP), please find enclosed an Application for a Permanent Water Right Transfer involving water right certificates 31423, 23974, and 33596. Please also find enclosed a check in the amount of \$2,700 for payment of the application filing fee.

The transfer application proposes changes to the portion of the water rights associated with property owned by RFP, which amounts to 99% of the authorized place of use (all three certificates have a coincident place of use) being an 894 acre-foot portion of Certificate 31423, a 0.74 cfs portion of Certificate 23974, and a 0.74 cfs portion of Certificate 33596. The changes proposed by the transfer application include a character of use change for all three water rights and an additional point of diversion for two of the water rights (Certificates 31423 and 23974).

**Additional remarks: The location of the reservoir footprint is clarified (re-described) based on current and past aerial photographs and the final proof survey map produced by the Department for Certificate 33596 which agree with the place of use description provided in Table 2 above. The discrepancies in the place of use listing on Certificate 31423 appear to result from 1) a shift in the PLSS grid approximately 300 feet to the south and 2) scrivener errors in the description of the place of use on the certificate (the place of use listing omits portions of the place of use that are shown on the accompanying map, including the SWSE as projected in DLC 47 of Section 18 and the NESW as projected in DLC 49 of Section 18).**


