A property line agreement left the POA for Cert. 39081 on adjoining property so it is proposed to add wells 1 and 2 as APOAs. T-7126 added APODs to all farm surface water rights but missed Cert. 81572. So it is proposed to add Lake 3 and River 2 and 3 as APODs for more efficient irrigation.

Narrative (Cert. 39081)

I assisted David Bateman in doing field surveying to establish the property boundary between David and Joan Setniker and ACMPC Oregon 1, LLC (Humbug Farms). (See attached survey map.) Our field work of locating physical features on the ground and found survey monuments verifies that the section line grid on the Final Proof Survey Map for Cert. 39081 (54.8 ac. primary water right) is shifted approximately 250' to the west from where the section lines should be shown. This is in agreement with OWRD findings on adjacent Cert. 57268. (See attached T-7126 Final Order, page 6, note under item 11.) (Also see attached T-7126 Research Report by Don Knauer and Proposed Revisions to T-7126 COBU item 3 by Will McGill. By making this correction, the water right foot print for Cert. 39081 will fit the farmed field it was intended to cover and avoids overlaps and gaps with adjoining water rights. This correction would put the 54.8 acre primary water right Cert. 39081 in agreement with the newly issued 54.8 acre supplemental water right Cert. 91986.
