SUBJECT: Water Right Transfer Application T-12185

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-12185. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication and in The Dalles Chronicle newspaper, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the last date of newspaper publication.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

Authority

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

Findings of Fact

- 1. On October 13, 2015, John McElheran filed an application to change the place of use and character of use under portions of Certificates 77326, 77733 and 76971. The Department assigned the application number T-12185.
- 2. Notice of the application for transfer was published on October 20, 2015, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On April 27, 2017, and June 1, 2017, the agent for the applicant submitted a revised application to clarify the places of use. On June 22, 2017, the agent for the applicant submitted another revised application to describe the place of use.
- 4. On June 30, 2017, the Department sent a copy of the draft Preliminary Determination proposing to approve Transfer Application T-12185 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of July 31, 2017, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

13. Certificate 77326 contains a scrivener's error in its quarter-quarter description for the Point of Diversion (POD) for the Clear Creek diversion described above in Findings Nos. 4 and 6. The certificate incorrectly lists the quarter-quarter as the NW½ SE½, Section 10. Based on the Juniper Flat District Improvement Company's HB3111 maps and the applicant's Certified Water Rights Examiner's current (Toll/2015) map based on a recent field visit and subsequent survey, the Department is led to conclude that Certificate 77326 should be corrected to reflect the correct quarter-quarter description within the NE½ SE¼, Section 10.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 14. Water has been used within the five-year period prior to submittal of the transfer application according to the terms and conditions of the rights. There is no information in the record that would demonstrate that these rights are subject to forfeiture under ORS 540.610.
- 15. Diversion structures, a well, ditches and district delivery system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-12185.
- 16. The proposed changes would not result in enlargement of the rights. The change in place of use of supplemental water right Certificate 76971 separately from its associated District primary water right to another place of use under the same District primary passes the "similar reliability" test and complies with OAR 690-380-2240(5).
- 17. The proposed changes would not result in injury to other water rights.

Partial Cancellation of a Water Right

18. On June 12, 2017, the Department received voluntary cancellation affidavits from John McElheran and Roseann McElheran, requesting to cancel a portion of Certificate 76971 appurtenant to Tax Lot 3000, within Sections 14 and 23, Township 4 South, Range 13 East, W.M.. The intent of the affidavits was to cancel the 45.4 acres without cancelling any quantity of water. Because Certificate 76971 authorizes a rate that is less than the full rate (i.e., 1/80 cfs per acre multiplied by the number of acres allowed under the certificate) and because the total allowed quantity of water (0.89 cfs) divided by the number of remaining acres (83.6) does not exceed 1/80 cfs per acre, the cancellation of 45.4 acres without reducing the total quantity of water may be authorized.

Determination and Proposed Action

The changes in place of use and change in character of use proposed in Transfer Application T-12185 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved and the abandoned water right portion will be cancelled.

If Transfer Application T-12185 is approved, the final order will include the following:

- 1. The changes in place of use and change in character of us proposed in Transfer Application T-12185 are approved. The portion of the water right that has been abandoned is cancelled.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 77326, 77733 and 76971, and any related decree.
- 3. Water right Certificate 76791 is cancelled. A certificate will be issued for that portion of this certificate NOT affected by this transfer.
- 4. Water right Certificates 77326 and 77733 are modified. The Department will issue superseding certificates describing the rights when it is determined that it is necessary for record keeping. The Department shall also make the needed revision to correct the POD description for the Clear Creek diversion in Certificate 77326 as described above in Finding No. 11 at that time.
- 5. The Director requires all existing meters to be maintained by the district, consistent with all permitted and certificated water uses.
- 6. The former places of use of the transferred rights shall no longer receive water under the rights.
- 7. The approved changes shall be completed and full beneficial use of the water shall be made on or before **October 1, 2018**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

8. After satisfactory proof of beneficial use is received, a new confirming right certificate shall be issued for Certificate 76971.
