*Example for Line 5a calculation to transfer 45.0 acres of Primary Certificate 12345 (total 1.25 cfs for 100 acres) and 45.0 acres of Supplemental Certificate 87654 (1/80 cfs per acre) on the same land:

1. For irrigation calculate cfs for each water right involved as follows:
 - a. Divide total authorized cfs by total acres in the water right (*for C12345, 1.25 cfs + 100 ac*); then multiply by the number of acres to be transferred to get the transfer cfs (*x 45 ac = 0.56 cfs*).
 - b. If the water right certificate does not list total cfs, but identifies the allowable use as 1/40 or 1/80 of a cfs per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (*For C87654, 45.0 ac x 0.0125 cfs/ac = 0.56 cfs*)

Description of Water Delivery System

System capacity: 0.40 cubic feet per second (cfs) OR

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines, and sprinklers used to divert, convey, and apply the water at the authorized place of use. Water is diverted from the well using a 20-hp submersible pump. The water passes through a manifold connecting to four pressure tanks and then to an approximately 5,200-gallon storage tank. A 25 hp pump forwards the water from the tank to mixer-truck wash racks, a slump rack, a boiler and hose bibs used for general site cleanup.

The 20-hp well pump delivers 0.40 cfs, based on a pumping water level of 181.5 feet, 66 psi for the operating pressure and 2 feet of casing stickup (a total head of 351.1 feet). The 25-hp forwarding pump has a lift of 2 feet to the pump, a 60 psi operating pressure and 4 feet from the pump to the place of use (total head of 158.4 feet). The well pump is the system constraint. Details on the pumping system are contained in the October 4, 2011 Claim of Beneficial Use prepared by Skookum Water Associates Inc.
