We have purchased a farm with groundwater rights from certificate 93008. Well 1 (POA) for this groundwater right is owned by Lynn Pope, and we do not have access to use it to irrigate our farm. We are therefore trying to transfer the point of appropriation for our groundwater rights on our farm to Well 2 (APOA) which is located on our farm.

I am also asking that our transfer include a rotational use agreement option to be included. The rotational use agreement between the two holders of the existing water right could be used so that each water right holder could use the full 2.61 cfs rate of diversion on a rotational basis for each well.


