The proposed permanent transfer includes transferring a portion of the water and water right authorized under Certificate 81168 to provide irrigation to a recreational area and memorial park located on the Applicant's property. The transfer of POU area specifically entails the transfer of 4.0 acres from the "from" lands to the "to" lands, as depicted on the transfer application map. All irrigation systems necessary to irrigate the "to" lands are already in place and fully operational. The "to" lands were previously irrigated pursuant to temporary transfer T-11427.



2.9 cfs represents the maximum minimum rate of withdrawal (at 940gpm) of CRRC&MA Well No. 1 identified under Certificate No. 81168. Well No. 1 serves the lands subject to permanent transfer. The actual distribution system beyond the Well No. 1 pump (which is rated at 1200 gpm) possesses an operational capacity in excess of 1200 gpm.

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines and sprinklers used to divert, convey and apply the water at the authorized place of use.

Response:

Pursuant to Certificate No. 81168, water is currently distributed for irrigation from Crooked River Ranch Club & Maintenance Association (CCR) Well No. 1 to the "from lands" and other lands located in Section 14 and additional lands and ponds all located in Section 24. A description of the distribution system through which water from CRR Well No. 1 is made available for beneficial use on the "from lands" is provided below. A description of the remainder of the distribution system through which water from CRR Well No. 1 is made available for beneficial use on lands in Section 24 is provided under final proof documentation submitted in Application T-6828.

As of the date of this application, CRR has in place a complete irrigation system for the recreational area and memorial park (the "to lands") that shall be used to apply to beneficial use that portion of the water rights subject to transfer as proposed. These areas are located in Section 23 as shown on the accompanying map and straddle the 10-inch main line used to distribute water to lands in Section 24. Irrigation of the "from" lands

a. Piping

CRR Well No. 1 is equipped with a 150hp vertical turbine pump which discharges irrigation water to a distribution system initially consisting of a "T" to two separate 10-inch lines. One line off the "T" distributes water to the "from lands" and other contiguous acreage and the other line off the "T" distributes water to lands in Section 24. The main line off the "T" that is used to distribute water to the "from lands" is a 10-inch schedule 40 steel line which is connected to a number of 6-inch steel laterals. Each lateral is fitted with a sprinkler head approximately every 60 feet. Each lateral distributes water to approximately ten (10) sprinkler heads. The main line off the "T" that is used to distribute water to Section 24 is a class 160 PVC line and is shown on the accompanying map.

b. Sprinkler Heads

Make and Model: Rainbird Impact 70, 35 gpm each (approx. 60 total), all for irrigation of the "from lands."

Size: 1" inlet

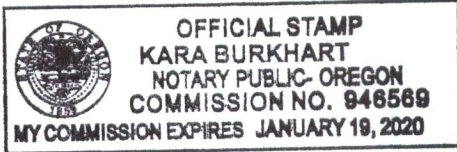

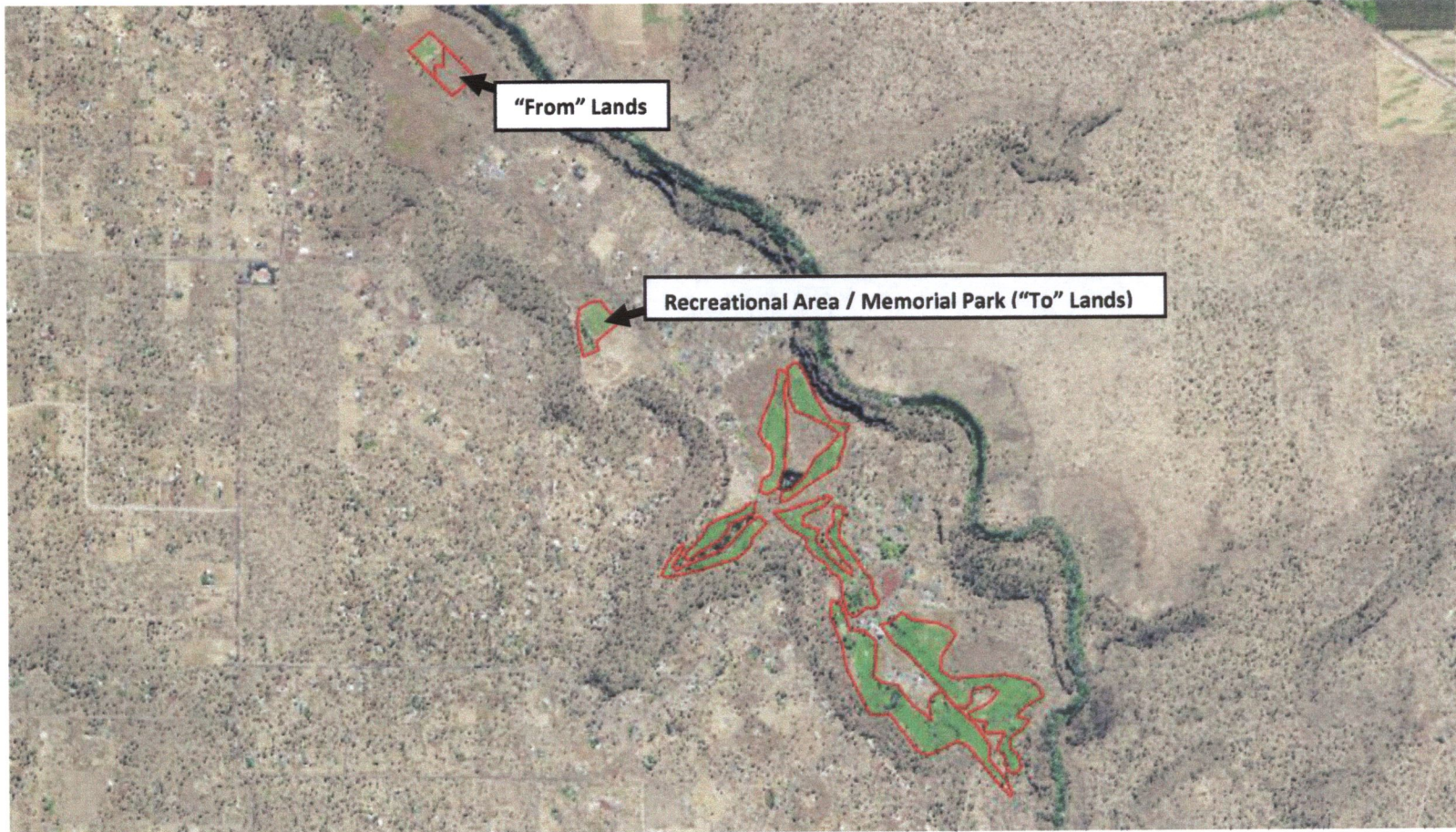
