**District Conveyance System:**

Description of Delivery System: Water is diverted from the Umatilla River into the Westland Canal at the Westland Dam. The Westland Canal delivers the authorized irrigation water ±3 miles to Westland Headgate #7 where Double "M" 100 hp variable drive centrifugal Cornel Pump is located on the South side of the Westland Canal. This pump station, delivers irrigation water to several 100 acres plus center pivots including the two 1.5 acre circles authorized in Transfer T-12414. The water is pumped through 930 ft of a 2000 ft buried 10 inch pvc pipe to a 4 in riser south east of this Pump Station. From this 4 inch riser the water is deliver through (380 ft westerly circle and 450 ft easterly) 4 inch aluminum hand line to a single Rain Bird 2004 Big Gun Sprinkler equipped with a 1.15 inch nozzle operated at 65 psi of pressure. This big gun is move between the two circles as crops required.
