\*Example for Line 5a calculation to transfer 45.0 acres of Primary Certificate 12345 (total 1.25 cfs for 100 acres) and 45.0 acres of Supplemental Certificate 87654 (1/80 cfs per acre) on the same land:

- For irrigation calculate cfs for each water right involved as follows:
  - Divide total authorized cfs by total acres in the water right (*for C12345, 1.25 cfs ÷ 100 ac*); then multiply by the number of acres to be transferred to get the transfer cfs (*x 45 ac = 0.56 cfs*).
  - If the water right certificate does not list total cfs, but identifies the allowable use as 1/40 or 1/80 of a cfs per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (*For C87654, 45.0 ac x 0.0125 cfs/ac = 0.56 cfs*)

The requested changes will allow the City to divert the water at a downstream point of diversion (POD) and use the water for municipal purposes inside the City's service area. The POD, place of use and character of use for the remaining portion of the right will not change. The City is also requesting 30 years to complete the transfer as indicated in an attached letter.

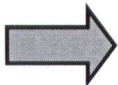

The pumps have 15-inch-diameter suction and 10-inch-diameter discharges. Water is conveyed from the pumps to the paper-mill water pond via 6,000 feet of 30-inch-diameter concrete pipe. Water from the pond is subsequently diverted to various locations on the mill property. The 7.7 cfs involved with this transfer is part of the 15 cfs in Certificate 54268 that is currently leased instream under IL-1434.**

Additional remarks: Certificate 54268 authorizes the use of up to 18.0 cfs for industrial/manufacturing use. The Applicant holds a 17.0 cfs portion of the right that is appurtenant to the "from" lands and is requesting approval to transfer 7.7 cfs of this rate to the City of Cornelius. The proposed change would reduce the authorized rate within the Applicant's entire place of use for Certificate 54268 to 9.3 cfs. A separate transfer, T-12773, if approved, would further reduce the 9.3 cfs by 2.0 cfs for a remaining right of 7.3 cfs. The POD, POU and character of use for the remaining rights will not change (i.e., the use will remain as industrial/manufacturing and the existing POD and POU will be retained). Currently, 15.0 cfs of Certificate 54268 are leased instream under IL-1434. Both the 7.7 cfs water right interest subject to transfer in this application and the 2.0 cfs water right interest subject to transfer in T-12773 are currently being administered under IL-1434.
