

Describe the current water delivery system or the system that was in place at some time within the last five years. Include information on the pumps, canals, pipelines, and sprinklers used to divert, convey, and apply the water at the authorized place of use. **Water is diverted from Neil Creek using a 2-hp Franklin Electric motor connected to a Century centrifugal pump. The water is applied using 440 feet of 2-inch-diameter PVC pipe connected to an Irripod Ranch Pack 5 pod system. Each nozzle can deliver 5 gpm for a total of 25 gpm.**

The lift from the creek to the pump is approximately 10 feet and the lowest place of use is about 5 feet higher than the pump. The system operates at approximately 50 psi. The Department's online pump calculator available to CWREs shows the pump's capacity is 0.09 cfs. The pod system can deliver 0.056 cfs.
