The intent is to have both transfers processed concurrently to maintain the ability to use a pivot on those lands.

Water from the bulge is then forwarded by a 6.5-hp pump to the places of use. The water is applied for irrigation using up to 50 sprinklers with 9/64-inch nozzles.

The 5-hp diversion pump is estimated to produce 250 gpm against an open discharge (0.56 cfs) based on field information.

The 6.5-hp forwarding pump is mounted at the bottom of the bulge, providing positive head. The place of use is about the same elevation as the pump and the operating pressure is approximately 50 psi. The online CWRE pump calculator indicates the capacity of the forwarding pump is 0.36 cfs.

The 9/64-inch nozzles each deliver 4 gpm at 50 psi according to tables in the Department's Claims of Beneficial Use so 40 nozzles would deliver about 0.36 cfs.
