Mr. Courchane:

On behalf of the applicant, City of Woodburn (City), GSI Water Solutions, Inc. (GSI) is providing revisions to groundwater registration modification application T-12183 that is on-file at the Department. The existing application requests eight (8) new Points of Appropriation and a new Place of Use corresponding to the City's water service area.

Revisions to Modifications Requested




