SUBJECT: Water Right Transfer Application T-12404

Please find enclosed the revised Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-12404. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the Department's notice.

If no protest is filed, the Department will issue a Final Order consistent with the revised Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the revised Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

Authority

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Applicant

WAIBEL RANCHES, LLC BOB WILLIAMS 3672 JUNIPER CANYON RD PRINEVILLE, OR 97754

Findings of Fact

- 1. On June 6, 2016, WAIBEL RANCHES, LLC, by BOB WILLIAMS filed an application for additional points of diversion, to change the points of diversion, and to change the place of use under Certificates 667, 34225, 37548, 52351, 52354, 52520, 55659, 75947, 84191, 84192, 84304, 84305, 89146, 89147, 89148, and 89610. The Department assigned the application number T-12404.
- 2. Notice of the application for transfer was published on June 14, 2016, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On August 2, 2018, the Department contacted the applicant by written correspondence to notify the applicant and the applicant's agent of the deficiencies in the application. The Department requested that the deficiencies be resolved by September 17, 2018.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 4. On September 7, 2018, the applicant's agent responded to one of the deficiencies involving Certificates 75946 and 75947. The District 11 Watermaster was concerned that the lands changing place of use under Certificates 75946 and 75947 would continue to receive water due to sub-irrigation from the source. The applicant's agent identified that the applicant would plow a ditch along the cut off line to force the water back to the North Fork Crooked River.
- 5. On September 10, 2018, the District 11 Watermaster responded and agreed with the actions described by the applicant's agent.
- 6. On September 13, 2018, the applicant submitted a revised Table 2 for Certificate 52520.
- 7. On October 24, 2018, the applicant submitted additional Evidence of Use supporting documentation.
- 8. On November 16, 2018, the applicant's agent submitted an Affidavit for the Voluntary Cancellation of a Portion of Water Right Certificate 52520, resolving the deficiencies.
- 9. On January 21, 2019, the applicant's agent submitted a revised map and table for Certificates 55659 and 84304.
- 10. On February 28, 2019, the applicant's agent submitted revised maps and tables for Certificates 52520, 89147, 89610, and 55659, and an Affidavit for the Voluntary Partial Diminution of Certificate 89148, resolving the deficiencies.
- 11. On May 7, 2019, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-12404 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of June 7, 2019, for the applicant to respond. The applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 12. On August 9, 2019, the applicant's Certified Water Rights Examiner identified scrivener's errors in the Preliminary Determination:
 - The season as described on Certificate 667 is incorrect. The original certificate identified July 1 to September 15 as the irrigation season, however, as evidenced by Department documents dated January 19, 1968, and a notation on the original certificate clarified the duration of the irrigation season should conform to the season as described in the Crooked River Decree, being February 1 to December 1;
 - The proposed place of use under Certificate 84304 was revised February 19, 2019, correcting the location of the place of use, not the amount of acres moving;
 - The proposed place of use under Certificate 89610 was revised February 28, 2019, correcting the location of the place of use, not the amount of acres moving;

- 10.0 acres of supplemental irrigation as identified in the application under Certificate 52520, was not included in the draft Preliminary Determination or the Preliminary Determination;
- The applicant requested an additional point of diversion under Certificate 52351, not a change in point of diversion;
- The change in points of diversion under Certificates 84305 and 84192 are moving downstream, not upstream; and
- The applicant requested to cancel a portion of acres under Certificate 89147. The Department determined a portion of the rate authorized by the certificate would not be cancelled, as the right was considered to have a deficient rate, and enlargement of the right would not occur.

59. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is not currently equipped with an appropriate fish screening and/or by-pass device. Transfer Review Criteria [OAR 690-380-4010(2)]

- 60. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 61. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-12404.
- 62. The proposed changes would not result in enlargement of the rights. The District 11 Watermaster identified the former place of use under Certificate 75947 would continue to be irrigated once the transfer is completed. The applicant has agreed to additional conditions to prevent enlargement of the right.
- 63. The proposed changes would not result in injury to other water rights.
- 64. All other application requirements are met.

Determination and Proposed Action

The changes in points of diversion, and changes in places of use proposed in Transfer Application T-12404 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000 and the abandoned rights should be cancelled. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved and the abandoned rights will be cancelled.

If Transfer Application T-12404 is approved, the final order will include the following:

- 1. The changes in points of diversion, and changes in places of use proposed in Transfer Application T-12404 are approved. The portions of the rights that have been abandoned are cancelled.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 667, 34225, 37548, 52351, 52354, 52520, 55659, 75947, 84191, 84192, 84304, 84305, 89146, 89147, 89148, and 89610, and any related decree.
- 3. Water right Certificates 667, 34225, 37548, 52351, 52354, 52520, 55659, 75947, 84191, 84192, 84304, 84305, 89146, 89147, 89148, and 89610 are cancelled. New certificates will be issued describing that portion of Certificates 75947, 89610, 55659, and 52520 not affected by this transfer and cancellation of Certificate 52520.
- 4. The quantity of water diverted at the new points of diversion (Diversion 1, Diversion 2A, Diversion 3A, and Sarvis Reservoir), shall not exceed the quantity of water lawfully available at the original points of diversion (Diversion 1, 2, 3, and 4, North Fork Crooked River, Crooked River, Sarvis Creek, and Mainline Reservoir #3).
- 5. Water use measurement conditions:
 - a. Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each new point of diversion.
 - b. The water user shall maintain the meters or measuring devices in good working order.
 - c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 6. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's (ODFW) design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Prior to submitting a Claim of Beneficial Use, the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to the state's criteria. The water user shall maintain and operate the fish

- screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.
- 7. The former places of use of the transferred rights shall no longer receive water under the rights.
- 8. In order to prevent enlargement under Certificate 75947, the applicant will plow a ditch along the cut off line to force the water to the North Fork Crooked River.
- 9. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2020**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 10. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
