of Roseburg , State of Oregon, 97470 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of North Umpqua River

a tributary of Umpqua River irrigating 4.5 acres

for the purpose of

under Permit No. 13694 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from

May 12, 1939 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.056 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{2}$ NW $\frac{1}{2}$, Section 33, T. 26 S., R. 6 W., W. M., being within Thomas Brown DLC 54.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre NE4 NW4
4.0 acres SE4 NW4
0.4 acre SW4 NW4
All projected within Thomas Brown DLC 54
Section 33
T. 26 S., R. 6 W., W. M.

An order of the Water Resources Director entered February 27, 1976 approved a change in point of diversion for the irrigation of 5.5 acres. This certificate is issued to confirm the remaining right not involved in the change and supersedes the certificate heretofore issued to Dale Guiley recorded at Page 13780, Volume 12, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described, and is subject to the existing minimum flow policies established by the Water Policy Review Board.
