Dear Sirs:

For land sales involving surface water rights for irrigation purposes, the statutes require a copy of the water right certificate be given the purchasers. This need not be a certified copy.

When a water right certificate is issued it is appurtenant to the land described in the certificate regardless of changes in ownership.

As long as the same diversion point is used for the irrigation of both parcels, the one certificate will suffice as evidence of the right. Statutes do not provide for reissuance of certificates for lands which are subdivided.

Enclosed you will find a copy of certificate recorded at page 45932, Volume 38, State Record of Water Right Certificates, along with our receipt number 16510 covering the copying fee of \$1.00 you submitted.

While in most cases the right described by the certificate will be valid, you are cautioned that the right or any part thereof may be lost through intentional abandonment or forfeited by five successive years of non-use. Our records will not show that any portion of a right has been lost until a cancellation proceeding has been completed.



, State of Oregon, 97470 proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of , has made

a tributary of Umpqua River the irrigation of 5.5 acres

for the purpose of

under Permit No. 13694 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 12, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.069 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NWk, as projected within Thomas Brown DLC 54, Section 33, T. 26 S., R. 6 W., W. M., 1030 feet South and 1390 feet West from the Nk Corner, Section 33

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited toone-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 21/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system a may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in point of diversion approved by an order of the Water Resources Director entered on February 27, 1976 and together with certificate of water right recorded on page 43562, Volume 35, State Record of Water Right Certificates supersedes certificate of water right recorded on page 13780, Volume 12, State Record of Water Right Certificates.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described. and is subject to the existing minimum flow policies established by the Water Policy Review Board.
