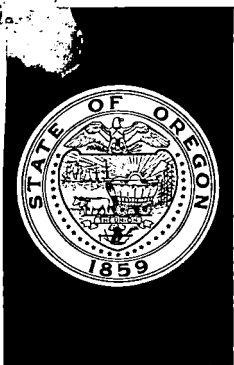

Dear Ms. McGaughey:

This will acknowledge your application for change in point of diversion of water from North Umpqua River, map and fees of \$37.00 for which our receipts No. 49094 and 49095 are enclosed. Your application has been filed as transfer No. 3300.

According to our records a point of diversion was established under the terms of permit No. 22673 between your original diversion point and your proposed diversion point. When there is an intervening diversion point, notice of the intended change must be published in a newspaper having general circulation in the county. For this we require a deposit of \$45.00. Any difference between the actual publication cost and deposit will be refunded. Will you also give us your choice of newspaper published in Douglas County for publication of the notice.

As soon as we receive the fee we will prepare a publication of notice to appear for three weeks in the designated newspaper to be followed by a hearing date. If there is no protest to the change an order will be prepared shortly after the hearing date.
