*Example for Line 5a calculation to transfer 45.0 acres of Primary Certificate 12345 (total 1.25 cfs for 100 acres) and 45.0 acres of Supplemental Certificate 87654 (1/80 cfs per acre) on the same land:

1. For irrigation calculate cfs for each water right involved as follows:
 - a. Divide total authorized cfs by total acres in the water right (for C12345, 1.25 cfs ÷ 100 ac); then multiply by the number of acres to be transferred to get the transfer cfs (x 45 ac = 0.56 cfs).
 - b. If the water right certificate does not list total cfs, but identifies the allowable use as 1/40 or 1/80 of a cfs per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (For C87654, 45.0 ac x 0.0125 cfs/ac = 0.56 cfs)

The Oregon Department of Fish and Wildlife (ODFW) supports the Kelley Creek Dam Removal Project within the Johnson Creek basin near 16600 SE Foster Road in Gresham Oregon. Fish passage projects are important for restoring listed stocks of salmon and steelhead species within the Lower Columbia River basin. This specific project is at a key location to increase connectivity between the upper and lower sub-basins, to connect fish with upper basin restoration projects and to improve stream channel function and associated habitat benefits for ESA listed species.

This project will remove a diversion dam that is blocking fish passage 0.75 miles upstream of the confluence with Johnson Creek. There will be approximately 1.9 miles of habitat opened upstream for salmonids as a result of this restoration project. The transfer of Point of Diversion is eliminating the current upstream gravity feed serviced by the dam, and moving it downstream about 250 feet where it will be serviced by a pump. ODFW has been working with the Johnson Creek Watershed Council (JCWC) at this location and will continue to show our support and in-kind contribution for these high priority projects for JCWC.
