Explain in your own words what you propose to accomplish with this transfer application, and why:
The property where the water right is being moved from, is being sold and will not be farmed. The receiving property will remain in farming and will benefit from the additional water. The Certificate does not have a rate, only a volume of 28.0 acre feet for the irrigation of 13.31 acres. The portion of the volume that is being moved is for the irrigation of 8.07 acres, leaving 5.24 acres of irrigated land in place. $8.07/13.31=60.63\%$. $28.0 \text{ AF} \times 0.6063 = 16.98 \text{ AF}$. This transfer will involve 16.98 AF. 11.02 AF will remain in place on the 5.24 acres.
The portion of the right being moved will make up a deficiency in the duty available from the stored water on the underlying right for irrigation on the "to" land. There will be no enlargement in the right as a result of this transfer.

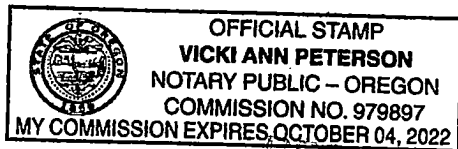
