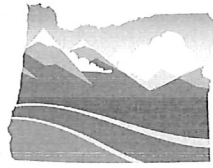

#11 is confusing as written. This application may involve micro-irrigation but not in the manner that I believe is intended for those questions. They are converting from macro-irrigation on the old greenwood tree farm back to circles. I selected NA. The "User Name" is "Canyon Farms II, LLC" on both "to" and "from" portions of the application. Why did "Frank Tiegs" need to sign an consent as landowner? Are they transferring water rights from his property to Canyon Farms? If so, this needs to be identified on "from" or "to" portions of the application.

b. The water user shall maintain the meters or measuring devices in good working order.

c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.

a. Before water use may begin under this order, the water user shall install **staff gages\***, or, with prior approval of the Director, other suitable measuring devices, that measure the entire range and stage between empty and full in each reservoir. Before water use may begin under this order, if the reservoir is located in channel, weirs or other suitable measuring devices must be installed upstream and downstream of the reservoir, and, an adjustable outlet valve must be installed. The water user shall maintain such devices in good working order. A written waiver may be obtained, if in the judgment of the Director, the installation of weirs or other suitable measuring devices, or the adjustable outlet valve, will provide no public benefit.
