Authority

Oregon Revised Statutes (ORS) 537.705 and 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of appropriation, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

1. On October 24, 2016, KENNETH AND LESLIE HUFFORD REVOCABLE LIVING TRUST, DBA HUFFORD ESTATE LLC, filed an application to change the points of appropriation and to change the place of use under Certificates 52635, 87207, 90484, 90486, 91427, 91428, and 91429. The Department assigned the application number T-12515.
2. Notice of the application for transfer was published on November 1, 2016, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
3. On March 16, 2017, the Department contacted the applicant by written correspondence to notify the applicant and the applicant's agent of the deficiencies in the application. Table 2 under Certificate 87207 did not correctly identify the amount of acres being transferred, Table 1 under Certificate 90486 did not correctly describe the authorized point of appropriation, and Table 2 under Certificate 91429 did not correctly describe the amount of

acres being transferred. The Department requested that the deficiencies be resolved by April 14, 2017.

4. On April 5, 2017, the applicant's agent submitted a revised Table 2 for Certificates 87207 and 91429.
5. On April 14, 2017, the applicant's agent submitted a revised Table 1 for Certificate 90486, resolving the deficiencies.
6. On October 18, 2019, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-12515 to the applicants. The draft Preliminary Determination cover letter set forth a deadline of November 19, 2019, for the applicants to respond. The applicants requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

Transfer Review Criteria (OAR 690-380-4010)

28. Water has been used within the last five years according to the terms and conditions of the rights. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
29. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-12515.
30. The proposed change would not result in enlargement of the rights.
31. The proposed change would not result in injury to other water rights.
32. All other application requirements are met.

Determination and Proposed Action

The changes in points of appropriation and changes in places of use proposed in Transfer Application T-12515 appear to be consistent with the requirements of ORS 537.705 and 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the application will be approved.

If Transfer Application T-12515 is approved, the final order will include the following:

- 1. The changes in points of appropriation and changes in places of use proposed in Transfer Application T-12515 are approved.*
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 52635, 87207, 90484, 90486, 91427, 91428, 91429, and any related decree.*

3. *Water right Certificates 52635, 87207, 90484, 90486, 91427, 91428, and 91429 are cancelled. New certificates will be issued describing those portions of the rights not affected by this transfer*
4. *The quantity of water diverted at the new point of appropriation (Well 6), shall not exceed the quantity of water lawfully available at the original point of appropriation (Well 2), under Certificate 52635.*
5. *The quantity of water diverted at the new point of appropriation (Well 6), shall not exceed the quantity of water lawfully available at the original point of appropriation (Well 1), under Certificates 87207 and 90484.*
6. *The quantity of water diverted at the new point of appropriation (Well 6), shall not exceed the quantity of water lawfully available at the original point of appropriation (Well 6), under Certificate 90486.*
7. *The quantity of water diverted at the new point of appropriation (Well 6), shall not exceed the quantity of water lawfully available at the original point of appropriation (New Well 1), under Certificates 91427 and 91429.*
8. *The quantity of water diverted at the new point of appropriation (Well 6), shall not exceed the quantity of water lawfully available at the original point of appropriation (New Well 1 and New Well 2), under Certificate 91428.*
9. *Water use measurement conditions:*
 - a. *Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of appropriation (new and existing).*
 - b. *The water user shall maintain the meter or measuring devices in good working order.*
 - c. *The water user shall allow the Watermaster access to the meter or measuring devices; provided however, where the meter or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.*
10. *Water shall be acquired from the same aquifer (water source) as the original points of appropriation.*
11. *The former place of use of the transferred rights shall no longer receive water under the rights.*
12. *Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2021**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.*

13. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-12515. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication and in the Lake County Examiner newspaper, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the last date of newspaper publication.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.
