This 4 year old Pipe line is referred as the Heppner to Lexington Pipeline. This pipe line and POD was designed and constructed under supervision of the USDA Natural Resources Conservation Service. T-11699 approved Transfer change for 12 water rights their POD to the POD of the Heppner to Lexington Pipe Line.
