The applicant is asking to transfer the diversion point onto their property and due to the characteristics of the ground at the site being level and close proximity of the original diversion point that a well would be using the same water as the original diversion point would have been using.



- Failure to complete an approved change in place of use and/or change in character of use, will result in loss of the water right (OAR 690-380-6010).

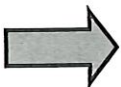

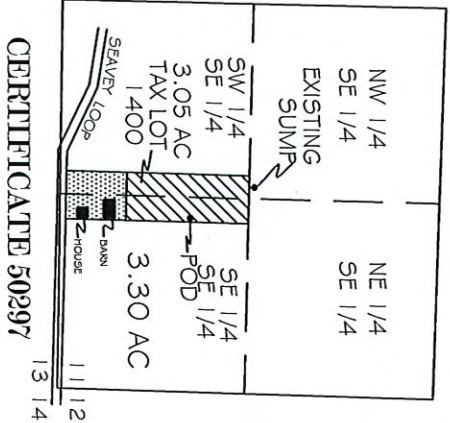
