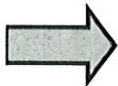

Water is being pumped from a small push up dam diversion in Jump Off Joe Creek to a bulge in system where it subsequently applied to the place of use via a pressurized pipeline. Several improvements were made to the diversion and infrastructure in the 2017 & 2018 irrigation season. Water is applied via overhead sprinklers, wheel lines, drip irrigation, and hand watering at the place of use.
