*The water is diverted from Thomas Creek by a fairly new diversion and fish screen. There is a 15-inch PVC pipe for the first 3320 feet of the system. There is approximately 5800 feet of open ditch to the place of use. The open ditch crosses the Lakeview Water Users canal and runs both north and south to flood irrigate the POU located east of the LWU canal. Recently a bulge in the system was installed to accumulate the flow during low flow periods so the storage could be used for surge irrigation. The bulge will be used to ensure a steady supply for the pivot that is being installed.*

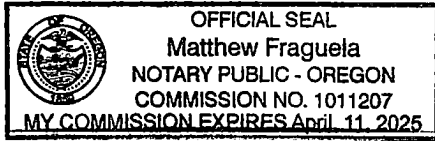
