Authority

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

ORS 540.621 establishes the process for the owner of land to which a water right is appurtenant to certify under oath that the water right, or a portion thereof, has been abandoned and to voluntarily request that it be cancelled.

Applicant

Findings of Fact

- On September 4, 2020, JOHN CHILDS filed an application for an additional point of diversion under Certificate 20351, to change the points of diversion under Certificates 20351, 27941, 47384, 55068, and to change the places of use under Certificates 20351, 27941, and 47384. The Department assigned the application number T-13518.
- 2. Notice of the application for transfer was published on September 29, 2020, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.

Pursuant to QAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 3. On December 19, 2020, the Department sent a deficiency letter to the applicant and agent, requesting revisions be made to the application, listing the measured distances of the points of diversion for Certificates 20351 and 27941.
- 4. On December 22, 2020, the agent for the applicant replied in writing with the revisions.
- 5. On January 23, 2021, the Department sent a deficiency letter to the applicant and agents, requesting for application revisions with a due date of February 22, 2021.
- 6. On February 22, 2021, the agent for the applicant requested an extension of the deficiencies deadline. On February 23, 2021, the Department extended the deficiencies deadline to March 12, 2021.
- 7. On March 12, 2021, the agent for the applicant emailed the revisions, including new application tables and maps and notarized Affidavits for the Voluntary Cancellation of a Portion of a Water Right Certificate (ORS 540.621).
- 8. On April 17, 2021, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-13518 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of May 17, 2021, for the applicant to respond. The applicant provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.
- 9. On May 26, 2021, agent requested that completion date be extended to October 1, 2024, siting development of the landscape.

- 7. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's (ODFW) design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Prior to submitting a Claim of Beneficial Use, the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to the state's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.
- 8. The former places of use of the transferred rights, Certificates 20351, 27941, and 47384, shall no longer receive water under the rights.
- 9. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2024**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.
- 10. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.

Transfer Review Criteria [OAR 690-380-4010(2)]

- 31. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 32. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-13518.
- 33. The proposed changes would not result in enlargement of the rights.
- 34. The proposed changes would not result in injury to other water rights.
- 35. All other application requirements are met.

Determination and Proposed Action

The additional point of diversion, change in points of diversion, and changes in place of use proposed in Transfer Application T-13518 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved.

If Transfer Application T-13518 is approved, the final order will include the following:

- 1. The additional point of diversion, changes in points of diversion, and in places of use proposed in Transfer Application T-13518 are approved. The portions of the rights that are abandoned, are cancelled.
- 2. The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 20351, 27941, 47384, and 55068 and any related decree.
- 3. Water Right Certificates 20351, 27941, 47384, and 55068 are cancelled.
- 4. Under Certificate 20351, the quantity of water diverted at the new additional point of diversion (Proposed Point of Re-Diversion from Reservoir) together with original POD (Authorized POD from an Unnamed Stream), shall not exceed the quantity of water lawfully available at the original point of diversion, (Authorized POD from an Unnamed Stream).
- 5. Under Certificate 20351, the quantity of water diverted at the new point of diversion (Proposed POD from an Unnamed Stream), shall not exceed the quantity of water lawfully available at the original point of diversion (Authorized POD from an Unnamed Stream).
- Under Certificates 27941, 47384, and 55068, the quantity of water diverted at the new points of diversion (Proposed POD from an Unnamed Stream and Proposed Point of Rediversion from Reservoir), shall not exceed the quantity of water lawfully available at the

The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the Department's notice.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.
