Explain in your own words what you propose to accomplish with this transfer application, and why:

The application proposes to move water rights from one location to another. The initial part of the application moves the remainder of water rights on lands previously owned by the Speer family to lands owned by Oregon Berry. The Speer rights are for live (surface) flow and are being moved downstream with a new Point of Diversion being required. The Speer water rights are on land no longer owned by the Speers, but the rights have been quitclaimed to Speers and therefore, they remain in Speer's control. Oregon Berry has water rights currently on their land, and they are moving some of those rights to an adjoining property and moving parts of their current rights around mainly to avoid layering of the water rights as much as possible, but also to best utilize the various rights. Tualatin Valley Irrigation District (TVID) is a small portion of this transfer, and TVID is been coordinated with. A Groundwater Registration (GR) Modification is also being done concurrently with this transfer because the GR is layered with certain current Oregon Berry rights.
