SUBJECT: Water Right Transfer Application T-13548

Please find enclosed the Preliminary Determination indicating that, based on the information available, the Department intends to approve application T-13548. This document is an intermediate step in the approval process; water may not be used legally as proposed in the transfer application until a Final Order has been issued by the Department. Please read this entire letter carefully to determine your responsibility for additional action.

A public notice is being published in the Department's weekly publication and in the East Oregonian newspaper, simultaneously with issuance of the Preliminary Determination. The notice initiates a period in which any person may file either a protest opposing the decision proposed by the Department in the Preliminary Determination or a standing statement supporting the Department's decision. The protest period will end 30 days after the last date of newspaper publication.

If no protest is filed, the Department will issue a Final Order consistent with the Preliminary Determination. You should receive a copy of the Final Order about 30 days after the close of the protest period.

If a protest is filed, the application may be referred to a contested case proceeding. A contested case provides an opportunity for the proponents and opponents of the decision proposed in the Preliminary Determination to present information and arguments supporting their position in a quasi-judicial proceeding.

**IMPORTANT:** Due to COVID-19, the Department's office is closed to walk-in services. The Department encourages the submission of protests by U.S. mail. Please consider mailing early to ensure the Department receives the protest by the deadline specified above.

# **Authority**

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

#### **Applicant**

#### **Findings of Fact**

- 1. On November 24, 2020, JB LAND LLC c/o GREG JUUL filed an application for additional points of diversion and to change the places of use under Certificates 89856 and 89858. The Department assigned the application number T-13548.
- 2. Notice of the application for transfer was published on November 24, 2020, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
- 3. On May 15, 2021, the Department mailed a copy of the draft Preliminary Determination proposing to approve Transfer Application T-13548 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of June 14, 2021, for the applicant to respond.
- 4. On May 26, 2021, the agent for the applicant requested the completion date to be extended to October 1, 2026, based on the permits needed and requirements from other agencies.

Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

- 5. On June 8, 2021, the agent for the applicant sent the Department a map and an explanation that the flow meters are already in place and the watermaster has approved the current locations, which are located along the main pipelines some distance downstream from the points of diversion.
- 6. On June 23, 2021, the District 5 watermaster responded to the Department that he agrees with the change in location of the flow meters, based on the map sent in on June 8, 2021 from the applicant's agent.
- 7. On July 1, 2021, the Department determined a revised draft Preliminary Determination should be issued, as the conditions are modified based on Findings of Fact Nos. 4, 5, and 6.
- 8. On July 21, 2021, the Department mailed a copy of the revised draft Preliminary Determination proposing to approve Transfer Application T-13548 to the applicants. The draft Preliminary Determination cover letter set forth a deadline of August 20, 2021, for the applicant to respond. The agent for the applicant requested that the Department proceed with issuance of a Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to a diversion of ONE-SIXTIETH of one cubic foot per second, or its equivalent for each acre irrigated, and shall be further limited to a diversion of not to exceed 3.73 acre-feet per acre for each acre irrigated during the irrigation season of each year. The use shall conform to such reasonable

rotation system as may be ordered by the proper state officer.

- 15. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is not currently equipped with an appropriate fish screening and/or by-pass device. This diversion may be eligible for screening cost share funds.
- 16. Certain portions of the authorized place of use as described in Finding of Facts Nos. 9 and 12, above, are appurtenant to lands described under Permits S-55114, S-55262, and S-55263. These permits are for use of water from the Columbia River, tributary to the Pacific Ocean. The applicant has stated that these permits are not currently being exercised on lands appurtenant to the authorized place of use involved in this transfer.
- 17. Portions of the proposed place of use as described in Finding of Facts (FOF) Nos. 11 and 14, above, are appurtenant to lands described under Permits S-55114, S-55262, and S-55263. These permits are for use of water from the Columbia River, tributary to the Pacific Ocean. Use of water under these permits is subject to the following annual use condition:
  - a) If water from Permits S-55114, S-55262, and S-55263 are used for supplemental irrigation, then pre-existing primary rights for the same place of use cannot be transferred to another place or character of use.

#### Transfer Review Criteria [OAR 690-380-4010(2)]

- 18. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the rights are subject to forfeiture under ORS 540.610.
- 19. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing rights were present within the five-year period prior to submittal of Transfer Application T-13548.
- 20. The proposed changes would not result in enlargement of the rights.
- 21. The proposed changes would not result in injury to other water rights.
- 22. All other application requirements are met.

#### **Determination and Proposed Action**

The additional points of diversion and changes in place of use proposed in Transfer Application T-13548 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved.

If Transfer Application T-13548 is approved, the final order will include the following:

- 1. The additional points of diversion and change in place of use proposed in Transfer Application T-13548 are approved.
- The right to the use of the water is restricted to beneficial use at the place of use described, and is subject to all other conditions and limitations contained in Certificates 89856 and 89858, and any related decree.
- 3. Water right Certificates 89856 and 89858 are cancelled.
- 4. For Certificate 89856, the quantity of water diverted at the additional point of diversion (POD #2), together with that diverted at the original point of diversion (POD #1), shall not exceed the quantity of water lawfully available at the original point of diversion (POD #1).
- 5. For Certificate 89858, the quantity of water diverted at the additional point of diversion (POD #2), together with that diverted at the original point of diversion (POD #1), shall not exceed the quantity of water lawfully available at the original point of diversion (POD #1).
- 6. Water use measurement conditions:
  - a. The watermaster has approved flow meters located along the main pipelines, and no water withdrawals from the main pipelines between the points of diversion and the

locations of the flow meters, (new and existing, see attached map titled "Location of JB Land, LLC and Royale Columbia Farms Flow Meters), as follows:

- i. Royale Columbia Farms POD and Pumping Station: 2860 feet North and 70 feet East from the SW corner of Section 8, T5N, R30E, WM.
- ii. JB Land, LLC POD and Pumping Station: 460 feet North and 1680 feet East from the SW corner of Section 7, T5N, R30E, WM.
- b. The water user shall maintain the meters or measuring devices in good working order.
- c. The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.
- 7. Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's (ODFW) design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Prior to submitting a Claim of Beneficial Use, the water user must obtain written approval from ODFW that the required screening and/or by-pass device was installed to the state's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.
- 8. The former place of use of the transferred rights shall no longer receive water under the rights.
- 9. Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2026**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.

10. After satisfactory proof of beneficial use is received, new certificates confirming the rights transferred will be issued.
