

20. The proposed changes would not result in injury to other water rights.
21. All other application requirements are met.

Determination and Proposed Action

The change in point of diversion, change in place of use and change in character of use proposed in Transfer Application T-14099 appear to be consistent with the requirements of ORS 540.505 to 540.580 and OAR 690-380-5000. If protests are not filed pursuant to OAR 690-380-4030, the transfer application will be approved.

If Transfer Application T-14099 is approved, the final order will include the following:

1. *The change in point of diversion, change in place of use and change in character of use proposed in Transfer Application T-14099 are approved.*
2. *The right to the use of the water is restricted to beneficial use at the place of use described and is subject to all other conditions and limitations contained in Certificate 53653 and any related decree.*
3. *Water right Certificate 53653 is cancelled. A new certificate will be issued describing that portion of the right not affected by this transfer.*
4. *The quantity of water diverted at the new point of diversion shall not exceed the quantity of water lawfully available at the original point of diversion.*
5. *The diversion of water under the proposed municipal use shall be limited to 1.68 cubic feet per second and shall be further limited to a total volume diverted of 343.35 acre feet (76.3 acres x 4.5 acre feet per acre) during the time period March 1 through October 31.*
6. *Water use measurement conditions:*
 - a. *Before water use may begin under this order, the water user shall install a totalizing flow meter, or, with prior approval of the Director, another suitable measuring device, at each point of diversion.*
 - b. *The water user shall maintain the meters or measuring devices in good working order.*
 - c. *The water user shall allow the Watermaster access to the meters or measuring devices; provided however, where the meters or measuring devices are located within a private structure, the Watermaster shall request access upon reasonable notice.*
7. *Prior to diverting water, the water user shall install a fish screening and/or by-pass device, as appropriate, at the new point of diversion consistent with the Oregon Department of Fish and Wildlife's (ODFW) design and construction standards. Prior to installation, the water user shall obtain written approval from ODFW that the required screen and/or by-pass device meets ODFW's criteria. Prior to submitting a Claim of Beneficial Use, the water user*

11. Transfer Application T-14099 proposes a change in point of diversion approximately 2.1 miles downstream to:

12. Transfer Application T-14099 also proposes to change the place of use of the right to:

MUNICIPAL USE
WITHIN THE CITY OF UMATILLA WATER SERVICE AREA

13. Transfer Application T-14099 proposes to change the character of use to MUNICIPAL USE.
14. Certificate 53653 does not specify the irrigation season. However, consistent with the Columbia River rights, the irrigation season is March 1 through October 31.
15. The applicant does not meet the definition of a municipality ORS 540.510(3)(b). The transferred right will be lost if not assigned to and perfected by a municipality.
16. The Oregon Department of Fish and Wildlife (ODFW) has determined that a fish screening and/or by-pass device is necessary at the new point of diversion to prevent fish from entering the diversion and/or safely transport fish back to the body of water from which the fish were diverted and that the diversion is not currently equipped with an appropriate fish screening and/or by-pass device. This diversion may be eligible for screening cost share funds.

Transfer Review Criteria [OAR 690-380-4010(2)]

17. Water has been used within the last five years according to the terms and conditions of the right. There is no information in the record that would demonstrate that the right is subject to forfeiture under ORS 540.610.
18. A pump, pipeline, and sprinkler system sufficient to use the full amount of water allowed under the existing right were present within the five-year period prior to submittal of Transfer Application T-14099.
19. The proposed changes would not result in enlargement of the right, if conditioned so that the rate of diversion for the proposed municipal uses shall be limited to 1.68 cubic feet per second and shall be further limited to a total volume diverted of 343.35 acre-feet (76.3 acres x 4.5 acre-feet per acre) during the time period of March 1 through October 31.

Preliminary Determination and provided the necessary information to demonstrate that the applicant is authorized to pursue the transfer.

6. On March 28, 2023, the Department issued a Preliminary Determination proposing to approve Transfer Application T-14099 and sent a copy to the applicant. Additionally, notice of the Preliminary Determination for the transfer application was published in the Department’s weekly notice on April 4, 2023, and in the East Oregonian newspaper on March 30 and April 6, 2023, pursuant to ORS 540.520 and OAR 690-380-4020.
7. On April 5, 2023, it was discovered there was a scrivener’s error in irrigation season dates in finding of fact number 10 of the Preliminary Determination. The correct irrigation season is described below in finding of fact number 12.
8. On April 27, 2023, the Department sent a copy of a REVISED draft Preliminary Determination proposing to approve Transfer Application T-14099 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of May 27, 2023, for the applicant to respond. The applicant requested that the Department proceed with issuance of the Preliminary Determination.
9. The Preliminary Determination issued on March 28, 2023 is withdrawn and of no further force or effect.
10. The portion of the right to be transferred is as follows:

Certificate: 53653 in the name of L AND L FARMS (perfected under Permit S-42856)
Use: IRRIGATION of 76.3 ACRES
Priority Date: JANUARY 11, 1978
Rate: 1.68 CUBIC FEET PER SECOND
Limit/Duty: The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

Authority

Oregon Revised Statutes (ORS) 540.505 to 540.580 establish the process in which a water right holder may submit a request to transfer the point of diversion, place of use, or character of use authorized under an existing water right. Oregon Administrative Rules (OAR) Chapter 690, Division 380 implement the statutes and provides the Department's procedures and criteria for evaluating transfer applications.

Findings of Fact

1. On September 30, 2022, CLEAVER LAND, LLC, C/O ALAN CLEAVER filed an application to change the point of diversion, change the place of use and to change the character of use under Certificate 53653. The Department assigned the application number T-14099.
2. Notice of the application for transfer was published on October 11, 2022, pursuant to OAR 690-380-4000. No comments were filed in response to the notice.
3. On October 25, 2022, the Department sent an e-mail request to the agent to clarify the proposed lands and inquire about a receiving landowner.
4. On November 1, 2022, the agent for the submitted a revised Table 2 to redescribe the proposed lands.
5. On January 20, 2023, the Department sent a copy of the draft Preliminary Determination proposing to approve Transfer Application T-14099 to the applicant. The draft Preliminary Determination cover letter set forth a deadline of February 19, 2023, for the applicant to respond. The applicant requested that the Department proceed with issuance of a


Pursuant to OAR 690-380-4030, any person may file a protest or standing statement within 30 days after the last date of publication of notice of this preliminary determination.

must obtain written approval from ODFW that the required screening and/or by-pass device was installed to the state's criteria. The water user shall maintain and operate the fish screen and/or by-pass device, as appropriate, at the point of diversion consistent with ODFW's operational and maintenance standards.

8. *The former place of use of the transferred right shall no longer receive water under the right.*
9. *Full beneficial use of the water shall be made, consistent with the terms of this order, on or before **October 1, 2024**. A Claim of Beneficial Use prepared by a Certified Water Right Examiner shall be submitted by the applicant to the Department within one year after the deadline for completion of the changes and full beneficial use of the water.*
10. *After satisfactory proof of beneficial use is received, a new certificate confirming the right transferred will be issued.*
