The Lake County Umbrella Watershed Council and other stakeholders are improving fish passage and screening on Deep Creek, one of three primary tributaries in the Warner Basin used by Warner Sucker and Warner Lakes Redband Trout for spawning and rearing. The project will transfer water rights from an unscreened instream diversion to a screened pump station. The water rights transfer will allow for removing the instream concrete weir that is a partial fish passage barrier.

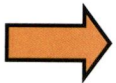



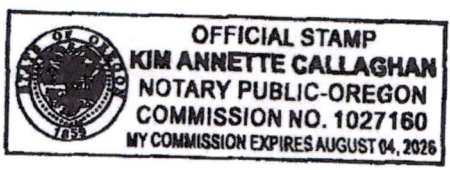
