1. For irrigation calculate cfs for each water right involved as follows:
 - a. Divide total authorized cfs by total acres in the water right (*for C12345, 1.25 cfs ÷ 100 ac*); then multiply by the number of acres to be transferred to get the transfer cfs (*x 45 ac = 0.56 cfs*).
 - b. If the water right certificate does not list total cfs, but identifies the allowable use as 1/40 or 1/80 of a cfs per acre; multiply number of acres proposed for change by either 0.025 (1/40) or 0.0125 (1/80). (*For C87654, 45.0 ac x 0.0125 cfs/ac = 0.56 cfs*)
2. Add cfs for the portions of water rights on all the land included in the transfer; however **do not count cfs for supplemental rights on acreage for which you have already calculated the cfs fee for the primary right on the same land**. The Vitiritti Family Farm LLC, existing property owner (tax map lot no. 05 1W 15, 01600) of irrigation lands, under Certificate 68344, is proposing to transfer 20.0 acres of authorized POU from lands to new POU lands for irrigation of crops and pasture. The proposed POD will be a new POA (well) proposed in this transfer application. The proposed new POA well would be constructed targeting the same aquifer system. The proposed well would be located on property tax lot 1600 of T.05S, R. 1W, Sec 15 and at least 1/4-mile from the nearest mapped stream.


